#### **CIRCULAR**

Applications are invited from the Officers and staff of this Institute for the preparation of a **Unified Waiting List** for Allotment/Change of residential quarters during the year 2023. The duly filled in application in the prescribed proforma (**Annexure-I**) may be submitted through e-office to the AAO (Estate) on or before 16.12.2022.

Applications are also invited from the <u>Non-eligible applicants</u> (on one step above category) for filling the <u>surplus vacant quarters available in Type-II and Type-III quarters</u>. The duly filled in application in the prescribed proforma (<u>Annexure-II</u>) may be submitted through e-office to the AAO (Estate) on or before 16.12.2022, subject to the following conditions:

- 1) The allotted higher entitled quarters will be deemed to be vacated within 15 days as and when the eligible person applied for the same.
- 2) In such circumstances, eligible quarters will be allotted at the time of vacation of the higher entitled quarters, if requested by the applicant. In case of non-availability of the eligible quarters, the applicant has to vacate the allotted higher type quarters immediately.
- 3) The junior most person (as per ICAR Service) in the non-entitled category shall be vacated initially, failing which, a triple rate of licence fee (or) the damaged rent will be levied as per rules.
- 4) Application for one step higher category will be considered only for the applicants, those who can reach the eligible pay level of the higher type quarters before his/her retirement.
- 5) An undertaking in the prescribed format has to be submitted while applying.

The details of entitlement of residential quarters are indicated below:
