I am writing to you regarding observation of 8th International Day of Yoga(IDY) on 21st June, 2022. As you are aware, at the initiative of Hon'ble Prime Minister, the United Nations General Assembly took a historic decision in 2014 to declare 21st June as the International Day of Yoga.
