OFFICE ORDER

The Govt. of Karnataka vide their orders No. RD 158 TNR 2020 dated 19.06.2021 has further extended the implementation of the guidelines to break the chain of COVID-19 transmission in the state and have ordered for functioning of establishments with 50% attendance from 6.00 AM of 21.06.2021 to 5.00 AM on 05.07.2021. Accordingly, the Competent Authority of this Institute has ordered that ICAR-CPCRI Regional Station, Vittal and ICAR-CPCRI Research Centre, Kidu shall function with 50% staff from 21.06.2021 to 05.07.2021.

- Head, CPCRI (RS), Vittal/Scientist in-charge, CPCRI (RC), Kidu may prepare a roster to regulate the attendance of officials working at RS/RC, and may, on administrative grounds, direct more officials to attend office
- 2. All officials who do not attend office on a particular day are to make themselves available on Telephone and other electronic means of communication at all times from their residence and work from home.
- 3. All officials residing in containment zones shall continue to be exempted from coming to office till the containment zone is de-notified.
- 4. Persons with Disabilities and Pregnant women employees may be exempted from attending office, but they shall continue to work from home.
- 5. Crowding in common areas is to be strictly avoided.
- 6. Meetings, as far as possible, to be conducted through video-conferencing.
- 7. Entry of outsiders/visitors to be curtailed appropriately.

All the employees and contractual staff attending the office during this period shall strictly comply with COVID-19 guidelines, viz. sanitizing, wearing face mask maintaining social distance etc.
