S.N. Query I Namitha M.S., cleared CSIR-JRF ICAR-CPCRI ioined 01.01.2019 at Kasaragod, Kerala to pursue PhD under the supervision of Dr. Anitha Karun, Director, ICAR-CPCRI, Kasaragod. For this I have enrolled in Department of Applied Botany under Mangalore University (Mangalagangothri, Dakshina Kannada District, Karnataka). As per the university rules I have to pay Rs.10,000 / - per annum as PhD program fee at Mangalore University. I received a letter from the HRD Cell Kasaragod ICAR-CPCRI, of demanding payment of Rs. 60,000 per annum as PhD remittance fee. The last date to pay the fee in HRD cell of ICAR-CPCRI was on 11/06/2020. But I did not pay the fee. Should I pay in both institute and university. How does this fee remittance work. I would like to know the details of the ICAR-CPCRI Kasaragod Office Order / Circular regarding PhD fees. Is there such a rule and is it valid. Kindly provide the details.

The office order directing Ms. Namitha M.S. to remit the applicable fees was issued from HRD Cell after due consideration of the approval in the Institute HRD case/ Committee/Director of the institute. in compliance of the extant ICAR "Guidelines for the students to conduct research for their trainees as programmes institutions" issued by ICAR vide its letter. F. NO. 2-8/2012-HRD dated 25th April, 2014. The aforementioned order of the Council is available in public domain (https://icar.org.in/files/RevisedGuidelinesfo rthestudentstoconductresearch25042014.pdf)

ICAR-CPCRI, a research institute under ICAR, charges the applicable fees from only those students enrolled/ registered for Ph.D in the University and undertaking the PhD research programme under the supervision of a Scientist/Research Guide at ICAR-CPCRI, a recognized Research Centre under the University. Students are permitted to undertake the Ph.D prgramme at this request/ specific based on institute application from the students and on the condition that they shall abide by all the provisions of the aforementioned HRD Guidelines, including payment of fees, as applicable.

Mangalore University charges fees from the students pursuing different courses under it as per their rules and regulations/with the approval of appropriate statutory authorities. All Ph.D. scholars are required to remit the applicable fees to the University directly, as stipulated by the University, regardless of whether they are pursuing their research work in the University Department or

recognized Research Centres.
