

1	How much a person has to pay for the institute to do PhD by registering in other universities?	As per the ICAR "Guidelines for the students to conduct research for their programmes as trainees at ICAR institutions" issued by ICAR vide its letter F. NO. 2-8/2012-HRD dated 25th April, 2014). The aforementioned order of the Council is available in public domain (https://icar.org.in/files/RevisedGuidelinesforth estudentstoconductresearch25042014.pdf). Students shall be uniformly charged a fee of Rs. 30,000/- per semester.
2	Whether student registering in university which is having MoU with CPCRI should also pay fees?	MOU is mandatory for students carrying out project work/PhD in case of other Institute/Universities at ICAR-CPCRI. Students registered with Agriculture University/Deemed University under NARS (National Agricultural Research System) are exempt from paying fee and others should have to pay fee as per guidelines.
3	On what basis the fee is collected from the students?	Refer reply in Q.1
4	Whether the fees will change for lab related research work and field related research work?	No. There is no change in fee depending on the nature of work.

5	Is there any fees concession for women candidates?	Yes; Women candidates have to pay only 50% of the fee.
