The quotations shall be opened after public auction at 03.30 pm on the same day itself i.e. on 06.10.2020 (Tuesday) .The terms and conditions are as given below:-

TERMS AND CONDITIONS

- 1. Bid should be submitted in the prescribed format and in sealed cover super-scribed as "Bid for the auction of Tata Sumo" due on 06.10.2020. The bid should be addressed to the "Principal Scientist & Head, ICAR-Krishi Vigyan Kendra, ICAR-CPCRI, RS, Kayamkulam 690 533 so as to reach on or before 06.10.2020 at 03.00 pm. This office shall not be responsible for any delay in postal transit. No bid shall be accepted after the due date and time. If the due date is declared as Govt. - 2. Bid should be signed by bidder/himself/themselves or a person duly authorized in this behalf. A copy of such authority should be enclosed along with the offer.

- 4. Bid will be opened only after public auction on 06.10.2020 at 03.30 pm in the presence of tenderers on the date of auction. If the date of opening of quotations happens to be holiday, then the quotations shall opened on the next working day of the same time.
- 5. Bidders can inspect the Tata Sumo during the office hours (10.00 am to 03.30 pm) in the above mentioned address from 23.09.2020 to 05.10.2020 in regard to the present condition of the Tata Sumo and satisfy themselves before submitting their offer by the date and time specified above.

- 11. Right to include any other conditions or modify or alter any of bid conditions already stipulated is reserved on the Head, ICAR-KVK-Alappuzha
- 12. Bidder will be deemed to have been on the clear understanding that they have satisfied themselves full in regard to the present condition of the Tata Sumo proposed to be auctioned
- 13. Payment and Deliveries
 - a) The successful bidder will be required to make full payment of bid by electronic transfer from his bank account or by DD in favour of ICAR Unit, CPCRI, payable at Kayamkulam within two days thereafter. Earnest Money Deposit shall be forfeited if the offer is withdrawn during the validity period.
 - b) The successful bidder will have to lift the Tata Sumo within two days after depositing the full bid amount as per terms and conditions of the bid. Delivery of the Vehicle shall be affected against receipt of payment by DD or electronic transfer. Any purchaser failing to lift the material within the above stipulated period, shall have to pay ground rent @10% of tendered value per week.  - c) EMD deposited shall be forfeited if any purchaser fails to lift the items after making full payment and expiry of periods as mentioned above. Thereafter KVK shall be entitled to resell these items. No notice shall be issued to the bidder in this regard.
