If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. 2. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

10. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. 11. Step by step QC reports are to be provided. Only after final approval from the PI, project should go forward.
12. The staff from institute would be involved in observing Sample preparation, Quality control on Qubit, Size selection, Library Preparation, Quality control of Library, filtering of raw reads and other contaminants, assembly construction (scaffold) and evaluation, annotation and other related work at the facilities of the firm concerned as per the resource availability.
13. No advance or part payment will be given.
14. Payment will be arranged only after satisfactory completion of all the items specified after due certification by the PI and Co-PIs. Payment will be made by e-payment or electronic transfer for which, the firm should provide bank details.
