Those who have PAN Card, GST registration, APMC licence and remit EMD can only submit the sealed tender/participate in the Public Auction. Public auction will commence at 11.30 AM on 15.09.2022 and the tenders will be opened after conclusion of the auction process. The EMD will be refunded to the unsuccessful bidders within 15 days of the auction.
