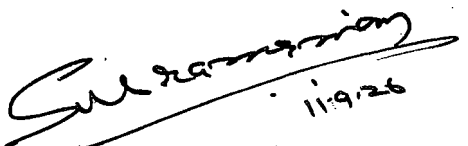

Tenders duly completed in all respects and sealed may be sent to the Director, ICAR CPCRI Kasaragod so as to reach the office on or before 23.09.2026 at 11.30AM along with the prescribed EMD (detailed as above) in the form of Demand Draft, drawn in favor of ICAR Unit, CPCRI Kasaragod payable at SBI, Kasaragod. A public auction will be conducted on the same day i.e., 23.09.2026 at 12.00 PM in the Institute premises. Those who submits the sealed tenders only can participate in the public auction. The sealed tenders will be opened after the public auction on the same day in the presence of tenderers present.

Terms and conditions of the Tender/Auction are given below. Further details, if any required, can be had from the scientist in-charge (Farm) of this Institute during the office hours.

Terms and Conditions

1. The bidder who wishes to participate in the auction may quote the rate per Cow/Calf listed above, after satisfying themselves seeing the livestock and strictly on the basis of 'as is where is' condition.
2. Tenders received without EMD will not be accepted.
3. Tenders received after the due date/time will not be accepted.

5. Auctioned livestock should be taken over 'as is where is condition' from the Mixed Farming Unit within 7 days of receipt of intimation letter, duly remitting the entire value of the sold livestock.
6. Failure on the part of the successful bidder in taking delivery of livestock from the Institute's Mixed Farming Unit within the stipulated time would be liable to pay penal fee ₹10/- per livestock per day.
7. EMD of the unsuccessful tenderers will be refunded within 7 days of opening the Tenders.
8. EMD of the successful tenderers/bidders will be refunded only after taken over the livestock.
9. The Director of the Institute will be at liberty to forfeit the EMD amount in full or part thereof in the event of not lifting the livestock within prescribed period.
