Tenders duly completed in all respects and sealed may be sent to the Director, Central Plantation Crops Research Institute, Kasaragod so as to reach the office on or before **17.02.2026 at 10.30AM** along with the prescribed EMD (detailed as above) in the form of Demand Draft, drawn in favor of **ICAR Unit, CPCRI, Kasaragod payable at SBI, Kasaragod**. A public auction will be conducted on the same day i.e., **17.02.2026 at 11.30 AM** in the Institute premises. Those who submits the sealed tenders only can participate in the public auction. The sealed tenders will be opened after the public auction on the same day in the presence of tenderers present.

Terms and conditions of the Tender /Auction are given below. Further details, if any required, can be had from the Scientist in-charge (Farm) of this Institute during office hours.

**Terms and Conditions**

1. The bidder who wishes to participate in the auction may quote the rate per 1000 nuts basis after satisfying the quality and on the basis "as is where is condition"
2. Tenders received without EMD will not be accepted
3. Tender received after the due date/time will not be accepted
4. No kind of sorting of nuts will be permitted at the time of lifting the nuts
5. Declaration of the highest bid will be done after opening the sealed tenders.
6. Auctioned nuts should be lifted "as is where is condition" from the store.
7. Lifting of the auctioned coconuts should be completed within 7 days of receipt of intimation letter, duly remitting the entire value of the sold coconuts.
8. Failure on the part of the successful bidder in lifting of auctioned coconuts from the Institute's godown within the permitted time would be liable to pay godown rent ₹ 10/- per thousand nut per day.
9. In the event of quoting same rate by more than one bidder, the decision will be arrived at on the basis of lots.
10. Loss or damage caused to the Institute properties while lifting the article, if any, would be made good or else necessary action will be initiated to recover the same.
11. EMD of the unsuccessful tenderers will be refunded within 15 days of opening the Tenders

12. EMD of the successful tenderers / bidders will be refunded only after completing the lifting of nuts.
13. The Director of the Institute will be at liberty to forfeit the EMD amount in full or part thereof in the event of not lifting the article within prescribed period,
14. The Director of this Institute reserves the right to accept or reject any tender without assigning any reason whatsoever, no claim on this account will be entertained in any case
15. The Director of the Institute reserves the right to cancel the tender at any time in case of violation of agreement.
16. If there any unexpected strike etc. the opening of tenders will be conducted the next working day of the notified date
