- 3. Harvesting work shall be done by contractor and commenced with the date of issue of order and will be completed within fifteen (15) working days under the supervision of Farm In-charge.
- 4. At least 13 Kg of fresh black pepper may be taken by the office from harvested fresh black pepper vines. The rate for the remaining fresh black pepper may be quoted per Kg basis. All works such as harvesting, transportation and weighing should be carried out by the party at his own cost.
- 5. The tender with the maximum rate will be accepted.
- 6. In case of failure to complete the work satisfactorily, the EMD amount will be liable forfeited.
- 7. Care should be taken to avoid any damage to new bunch/flower of Arecanut palms and Intercropping etc.,
