

The sealed quotation may be sent to the Head, ICAR- CPCRI, Regional Station, Kayamkulam so as to reach this Office on or before **09-06-2025 at 2.30 p.m.** The quotation shall be opened after public auction at 2.45 pm on the same day itself. Those who are interested to take part in the Auction/ Quotation may inspect the Trees in the Office premises during working hours of the Institute after obtaining prior permission from the SIC, Farm/Tech. Officer Farm. Further details, if any required, can be had from the SIC Farm/Tech. Officer (Farm) of this Institute during office hours.

## **Terms & Conditions:**

- 1. The Auction/Quotation without EMD will be rejected.
- The EMD may be paid by DD, drawn in favour of "ICAR Unit, CPCRI" payable at Kayamkulam. Those who are interested in both auction and quotation may deposit the EMD before the auction to this Office. However, those desirous of competing in the quotations only, may enclose the DD along with the quotations.
- 3. The amount should be quoted in both, figures and words, separately for each tree. The highest rate offered in the Auction/quotation shall be considered for acceptance.
- 4. The successful bidder on award of work shall have to immediately remit 10% of the bid amount. The EMD shall be refunded once the entire tree is removed from the premises of this Office after payment of the full bid amount.
- 5. The Head of the station reserves the right to accept or reject any quotation without assigning any reason whatsoever; no claim on this account will be

entertained in any case.

- 6. On acceptance of the quotation/auction price by the Competent Authority, the successful bidder will have to deposit the entire cost of Anjili Tree(s) within 3 days from the date of receipt of communication to that effect and the Trees should be lifted from the premises of this Regional Station within 3 days, failing which the EMD shall stand forfeited.
- 7. The bidder who wishes to participate in the sale may quote the amount for the entire quantity of the item of article mentioned above.
- 8. The rate quoted will be valid only for the particular Quotation.
- 9. The sealed tenders will be opened after auction, in the presence of tenderers on the date of auction.
- 10. Any loss or damage, etc., caused to the Institute properties while lifting the article should be made good or else necessary action will be initiated to recover the same.
- 11. The successful bidder may electronically transfer the cost of Trees (if he desire so to "ICAR-CPCRI (RS), Kayamkulam" from his bank account. Transferring the amount from a third party shall not be accepted.
- 12. The Head of the Institute reserves the power to cancel the quotation at any time in case of violation of the agreement.
- 13. If there is any sort of strikes etc. the opening of quotations will be conducted the next working day of the notified date.
- 14. Overwritten or corrected bids are liable to be disqualified unless these are legible and attested by the bidder.
- 15. The Head of the Institute will be at the liberty to forfeit the EMD amount in full or part, thereof in the event of not lifting the nuts within the prescribed period.
