Public auction will commence at 11.30 AM on 07.07.2020 and the tenders will be opened after conclusion of the auction process. The EMD will be refunded to the unsuccessful bidders within 15 days of the auction. The successful bidder will have to pay 10% of the bid amount immediately after the auction on confirmation and the balance amount in full with GST @5% within 15 days after clearing the APMC tax @1.5% etc. to the concerned department in addition to the bid amount, failing which the EMD and 10% of the bid amount will be forfeited and auction will be treated as cancelled.
