## Other Term and conditions:

The position is purely temporary and contractual basis. The services on the above position will stand terminated automatically after the expiry of the contract period or subject requirement of the services of the YP-I and Project Fellow in the organization and satisfactory as indicated in the offer letter after selection or till further orders from the council in this regard

- 1. The selected candidates have no right for absorption/regular appointment in ICAR-CPCRI.

- 3. The appointment will be subjected to the condition that the candidate is declared medically fit for service by the medical authority.
- 4. In case the candidate after appointment and joining wish to resign from the position before expiry of the contract he has to submit a notice giving one month time or should deposit one month pay in view of immediately relieving
- 5. The candidates should ensure their eligibility for the post before applying. Only those candidates having the educational qualifications and short listed will be called for the interview
- 6. No TA and DA will be paid to the candidates for attending the test and interview and or joining the position etc.
