### ENGAGEMENT OF MEDICAL OFFICER COINTRACTIAL BASIS

ICAR-Central Plantation Crops Research Institute, Regional Station, Krishnapuram Post, Kayamkulam – 690 533, Alappuzha Dist. proposes to engage a Medical Officer purely on Contractual basis from among the qualified registered medical practitioners residing in the locality of Alappuzha/Kollam Dist., for functioning as **PAR-TIME MEDICAL OFFICER** in the Regional Station dispensary.

#### Terms & Conditions of service shall be as follows:-

01.	Eligibility	Should be a MBBS Doctor with appropriate valid registration.
02.	Age	Should not have attained 60 years.
03.	Days and duration of visits	Thrice in a week (2 hours each day) either in the morning or afternoon.
04.	Location of Dispensary	Main campus of ICAR-CPCRI Regional Station, Kayamkulam.
05.	Remuneration	₹ . 15,000/= (including transportation).
06.	Conditions of service	Purely on Contract basis initially for a period of one year and extendable for further period.


Eligible and interest Medical Officers fulfilling the above criteria may send their bio-data and an application to the Acting Head, ICAR-CPCRI Regional Station, Krishnapuram Post, Kayamkulam – 690 533, Alappuzha Dist. latest by 30.11.2021. The contractual engagement shall be subjected to the following terms conditions:

**Term and Conditions:**

1. The Doctor is responsible to treat the employees/pensioners of this Institute by prescribing medicines for common disease for which he/she will be assisted by an employee of this Institute.
2. All the Medical Claims of the employees/pensioners who have taken treatment from him/her to be countersigned by the doctor engaged on contract basis.
3. He/She will be the authorized medical attendant for the employees/pensioners during his/her tenure as Part-Time Medical Officer.
4. The right to accept or reject the applications without assigning any reasons there of rest with the Acting Head of the Station. The Competent Authority reserves the right to terminate the contractual engagement of the Part-Time Medical Officer even before the expiry of tenure if his/her service is not found satisfactory.
5. The Doctor shall not be entitled to any other benefit like Provided Fund, Pension, Gratuity, Housing etc. or any other benefit available to the Govt. servants appointed on regular basis.
6. The Doctor will not have any claim or right for regular appointment to any post under ICAR-CPCRI.
7. Only consolidated remuneration will be admissible. No dearness allowance or any other allowance will be admissible to the Doctor.
8. The doctor is not entitled to any TA for joining at the place of posting on accepting appointment.
9. The Doctor is supposed to countersign the records maintained at Dispensary (OP register, other stock registers).
10. He/She will be the authorized medical attendance for issue of medical certificate of illness/fitness for leave on medical grounds after his careful examination of the staff.
