The quotations should confirm to the following terms & conditions:-

- 1. The rates quoted should be valid for a minimum period of 90 -120 days from the due date of receipt of quotation.
- 2. Complete description, specification of the item(s) quoted should be given.
- 3. Should indicate the rate of ST/CST/VAT/Entry Tax etc. if charged extra.
- 4. Should specify whether the item quoted are under DGS&D rate contract. If so details of the rate contract should be furnished with the quotation.
- 5. Quotation should clearly indicate the point of supply such as Ex-works/FOR despatch Station/FOR destination.
- 6. Earnest Money Deposit @ 2% of the quoted amount must be deposited by Demand Draft in favour of ICAR UNIT CPCRI (RS) Kayamkulam" on SBT Kayamkulam. Deposit at Call Receipt of the State bank of Travancore will also be accepted as earnest money provided the receipt obtained from the bank is attached with the quotation. Remittance of EMD in any other mode not acceptable.
- 7. TRANSIT INSURANCE : The purchaser will not pay separately for transit insurance and the supplier will be responsible until the entire stores contracted to arrive in good condition at destination.
- 8. The buyer shall have the right to levy liquidated damage at a percentage not exceeding 5% per each month or part thereof in respect of suppliers so delayed and delivered

- 9. Time required for effecting supply upon receipt of supply order should be indicated.
- 10. Guarantee offered for item(s) should be indicated from the date of receipt and installation of item(s).
- 11. Payment will be made only after satisfactory receipt and completion of installation of the item. No advance payment/part payment is admissible as per rules.

12. Quotation received after the due date will not be entertained.

- 13. The item ordered should be supplied in a lot. Part supply will not be accepted.
- 14. The rights to accept or reject the quotation rests with the Head, ICAR-CPCRI (RS) Kayamkulam.
