Interested parties may inspect the animals during the working hours of the Institute after obtaining prior permission of the ACTO farm/SIC farm/HD Crop Production. The tenders should be sent to the Director, Central Plantation Crops Research Institute, Kasaragod so as to reach the Office on or before 20.11.2017 at 5.00 PM along with an EMD of Rs 5,000/- (Rupees. Five thousand only) by Demand Draft, drawn in favour of "ICAR Unit CPCRI, Kasaragod" payable at SBI, Kasaragod. A Public auction also will be conducted on 21.11.2017 at 11.00 am in the Institute premises. Those who submit the sealed tenders only can participate in the public auction. The sealed tenders will be opened after the public auction on 21.11.2017 in the presence of tenderers present.

#### Terms and Condition:

- 01. The bidder who wishes to participate in the tender auction may quote the amount for the animals after satisfying the general health and other aspects of the animals mentioned above.
- 02. The rate quoted will be valid only for the particular Tender.
- 03. Tenders received after the due date and scheduled will not be accepted.
- 04. Tenders received without EMD will not be accepted.
- 05. The Public auction will be conducted on 21-11-2017 at 11. a.m. at the institute premises. Those who submit the sealed tenders only can participate in the public auction.
- 06. The sealed tenders will be opened after the public auction on 21-11-2017 in the presence of tenderers present.
- 07. The declaration of the highest bid will be done after the public auction and after opening of the sealed tenders.
- 08. The animals should be taken possession as is where is basis from the Institute premises.
- 09. The animals should be lifted as is where is basis from the mixed farming unit.
- 10. The lifting of animals should be completed within 7 days after receipt of intimation letter, duly remitting the entire value of the animals.

- 11. The bidder/ purchaser should give an undertaking that the animals are bought for agriculture purposes and not for slaughter. He/should provide his/her name. Address and also should furish his Identity proof (Election ID/Aadhar).
- 12. In case of quoting one and the same rate by two or more parties, the decision will be arrived at on the basis of lots/ negotiation.
- 13. The EMD of the unsuccessful bidders/tenderers will be refunded within 15 days of the auction/ opening of tenders.
- 14. The EMD of the successful tenderer/ bidder will be refunded only after three month s from the date of completing the lifiting of animals.
- 15. The Director of the Institute will be at liberty to forfeit the EMD amount in full or part there in the event of not lifting of the animals within prescribed period.
- 16. The Director of this Institute reserves the right to accept or reject any tender without assigning any reason whatsoever, No claim on this account will be entertained in any case.
- 17. The Director of the Institute reserves the power to cancel the tender at any time in case of violation of agreement.
- 18. If there any sort of strikes etc. the auction will be conducted the next working day of the notified date.
- 19. The bidder/purchaser of the animal gives a declaration that he shall not sell the animal up to six months from the date of purchase and shall abide by the rules relating to transport of animals made under the act or any other law for the time being in force and retain such record for a period of six months from the date of sale.
- 20. The bidder/purchaser should not sale the cattle to a person outside the state without the permission as per the state cattle protection or preservation act.
