Those who are interested to take part in the Auction/ Quotation may inspect the nuts in the Farm premises during working hours of the Institute after obtaining prior permission from the SIC, Farm/Tech.Officer Farm. Further details, if any required, can be had from the SIC Farm/Tech.Officer (Farm) of this Institute during office hours.

Terms & Conditions:

- 01. The Auction/Quotation without EMD will be rejected.
- 02. The EMD can be paid by DD only, drawn in favour of 'ICAR Unit, CPCRI' payable at Kayamkulam. Those who are interested in both auction and quotation may deposit the EMD before the auction to this Office. However who are desirous of competing, only in the quotations, may enclose the DD along with the quotations.
- 03. The highest rate offered in the Auction/quotation shall be considered for acceptance.
- 04. The amount quoted should be indicated both in figures and words.
- 05. The Head of the station reserves the right to accept or reject any quotation without assigning any reason whatsoever; no claim on this account will be entertained in any case.
- O6. In the event of accepting the quotation, the purchaser will have to deposit the entire cost of nuts offered for sale by DD, drawn in favour of 'ICAR Unit, CPCRI' payable at Kayamkulam within 3 days from the date of receipt of communication to that effect and the nuts should be lifted from the station premises within 3 days, failing which the EMD shall stand forfeited.
- 07. Good Quality nuts will not be changed, however barren nuts if any found in the lot will be replaced.
- O8. The bidder who wishes to participate in the sale may quote the amount for the entire quantity of each item of article mentioned above.
- 09. The rate quoted will be valid only for the particular Quotation.

- The sealed tenders will be opened after auction, in the presence of tenderers on the date of 10. auction.
