

1. The rates quoted should be valid for a minimum period of 90 days from the due date of receipt of quotations.
2. Complete description, specification of the item(s) quoted with a printed brochure should be enclosed for verification of technical specifications.
3. Should indicate time required for effecting the supply upon receipt of supply order.
4. Should indicate the rate of ST/CST/ED/VAT/Entry Tax etc. if charged extra.
5. Should specify whether the item(s) quoted are under DGS&D rate contract. If so, details of the rate contract should be furnished with the quotation.
6. The quotation should clearly indicate the point of supply such as Ex-works / FOR dispatch station / FOR destination

7. The buyer shall have the right to levy liquidated damages at a percentage not exceeding 2% per each month or part thereof in respect of supplies so delayed and delivered.
8. Guarantee offered for the item(s) should be indicated from the date of receipt of item.
9. Payment will be made only after satisfactory receipt of the item(s) by this office against supply order. No advance payment/part payment is admissible as per rules.
10. Quotations received after the due date will not be entertained.
11. The item(s) ordered should be supplied in a lot. Part supply will not be accepted. The right to accept or reject the quotation rests with the Director, CPCRI.
12. **TRANSIT INSURANCE:** The purchaser will not pay separately for transit insurance and the supplier will be responsible until the entire stores, arrived in good condition at destination.
13. **TIN/VAT/ST Reg.** no. should be indicated in the quotation.
14. **EARNEST MONEY DEPOSIT @2%** of the quoted amount, (if the quote exceeds Rs.100,000/-), **must be deposited by demand draft drawn in favour of "ICAR, Unit CPCRI, Kasaragod" payable at SBI, CPCRI Branch, Kasaragod** alongwith the quotation.

17. The successful tenders shall have to furnish an unconditional **performance security for an amount of 5% of the order value**, if the order value exceeds Rs.100,000/-. Performance security may be furnished in the form of demand draft/FD receipt or Bank Guarantee from a commercial bank in an acceptable form immediately after acceptance of the tender for placing the order. The performance security valid for a period for 60 days beyond the date of completion of all the contractual obligations including warranty should be furnished within 15 days of acceptance of order.
