  - as above. Bid forms are not transferable Bid should be signed by bidder/himself/themselves or a person duly authorized in this behalf. A copy of such authority should be enclosed along with
  - 3. The bidder may quote their bid both in figures and words. Overwriting or alterations will disqualify the bid unless these are legible and duly attested by bidder/bidders. Rates should be kept valid for acceptance at least for 90 days from the date of opening.
  - The public auction shall be held at 2.30 PM on 15/09/2015 and the sealed bids shall be opened there after on the same day.
  - Bidders can inspect the present condition of Tata Sumo (as and where it is basis) during office hours (09.30 am to 4.00 pm) at the above mentioned address from 04/09/2015 to 10/09/2015 and satisfy themselves before submitting their offer by the date and time specified above.

## 15. PAYMENT AND DELIVERIES

- 1. The successful bidder will be required to make full payment of bid by bank draft drawn on any nationalized bank in favour of ICAR Unit, CPCRI payable at Kayamkulam within two days thereafter. Earnest Money Deposit shall be forfeited if the offer is withdrawn during the validity period.
- 2. The successful bidder will have to lift the Tata Sumo & Two wheelers within two days after depositing the full bid amount as per terms and conditions of the bid. Delivery of the vehicle shall be affected against receipt of payment by DD. Any purchaser failing to lift the material within the above stipulated period, shall have to pay ground rent @ 10% of tendered value per week. The Institute will not be responsible for any loss or damage of the vehicles.
- 3. Earnest money deposited shall be forfeited if any purchaser fails to lift the items after making full payment and expiry of period as mentioned above. Thereafter CPCRI shall be entitled to resell these items. No notice shall be issued to the bidder in this regard.
- 4. The Purchaser will not be entitled to resell any vehicles while they are still lying within the CPCRI premises and no delivery would be affected by CPCRI to any person or persons other than the purchaser/purchasers whose name/names are mentioned in the delivery order.
- 5. The successful bidder before lifting the vehicles should contact the Officer in charge Vehicle, CPCRI, Kayamkulam to get the gate pass and delivery of vehicles.
- 6. Loading, handling, labour and transportation shall be the sole responsibility of the successful bidder at his/her own cost.
- 7. Loading and lifting of the vehicles shall be done by the successful bidder only during the prescribed working hours of the Institute and no delivery shall be affected during Sunday or
  - 8. The Head, CPCRI, Kayamkulam reserve the right to accept or reject any or all offer/bids either in full or in part without assigning any reason whatsoever.
  - 9. If, sufficient bids are not received, the Head, CPCRI, Kayamkulam reserves the right to call for fresh bids. In such an event Earnest Money deposited by the bidder shall be refunded.
  - 10. After lifting of the vehicles, the Earnest Money deposited by the successful bidder shall be refunded in full without any interest.
