

- 11. The person provided should maintain discipline in the premises of the Institute. The Contractor should obtain certificate of registration under contract labour (Regulation & Abolition) Act 1970, from the Regional Labour Commission (Central) Kochi and comply with all the provision of Act.
- 12. The Contractor/Agency shall be at the responsibility to comply with the requirements under the Labour Act/EPF Act/minimum wages Act etc. towards the personnel engaged for executing the contract work of this Institute
