

CPCRI, RS Vittal on Syndicate Bank, Vittal should reach the undersigned by 11.00 AM on 14-02-2020. Tenders without EMD will not be accepted. The auction will commence at 11.30 AM on 14-02-2020 at committee room and tenders will be opened after the auction procedures are over in the presence of the tenderer/bidders. Only those tenderers who have submitted their sealed tenders with the EMD will be allowed to participate in the public auction. The EMD of unsuccessful bidders (without intrest) will be refunded within 7 days after completion of the auction procedures. The tax imposed by the Government should be borne by the successful bidder. The successful bidder will have to pay 10% of the bid amount immediately after the confirmation and the balance in full with GST @5% within 10 days after clearing the APMC tax etc. to the concerned department in addition to the bid amount, failing which the EMD and 10% of the bid amount remitted are liable to be forfeited. APMC licenced holders/Bidders and who have GST registration certificate are only permitted to participate in auction. Copy of GST registration should be submitted along with tender form.
