DD along with quotation in sealed covers should reach this office on or before 12.00 noon on the same day. No tender will be accepted after the due date/time. Public auction will commence at 12.30 noon on 12-07-2017 and tenders will be opened after the auction in the presence of available tenderers. EMD in respect of the unsuccessful bidders will be refunded only after due process in the Office and will not be returned by hand at any cost on the same day. Transfer or adjustment of EMD/DD from one bidder to another will not be allowed. Bidders should maintain utmost discipline in the Auction Hall till the completion of the auction. The bidders in the Auction hall should not move from their seat during the time of auction without prior permission of the Competent Authority of this Institute. A copy of PAN and TIN may be produced by bidders while participating in the auction.
