# TENDER NOTICE

Acting Head, ICAR-CPCRI, Regional Station, Krishnapuram P.O. Kayamkulam is inviting sealed bids for disposal of unserviceable stores items (as per list attached) from the reputed and registered contractors/firms who possessing Certificate of State Pollution Control Board, Govt. of Kerala for e-waste disposal. The terms & conditions are given below.

#### **Terms & Conditions:**

- 01. The bidders shall quote rate for each item of unserviceable articles without any correction. Overwriting or alterations will disqualify the bid unless these are legible and attested by the bidder/bidders.
- 02. The format of the bid can be obtained from the office on any working day. Bids quoted in the prescribed format shall only be considered for acceptance. Bid forms are not transferable.
- 03. It may be ensured that item wise bid price should be recorded for LOT 'A' LOT 'B' and LOT 'C'.
- 04. Bid should be submitted in sealed cover super scribed as "Bid for disposal of unserviceable store items due on 16-08-2019". The bid should be addressed to the Asst. Administrative Officer, ICAR-CPCRI Regional Station, Krishnapuram P.O. Kayamkulam 690 533 on or before 16-8-2019 at 11.00 AM positively. This office shall not be responsible for any delay in postal transit. No bid shall be accepted after the due date & time. If the due date is declared as Government Holiday, the bid due date will be the next working day at the same time indicated as above.

- 05. Earnest Money Deposit (EMD): Each lot should be accompanied by an earnest money of **Rs.3000/- drawn in favour of ICAR Unit, CPCRI payable at Kayamkulam in the form of Demand Draft only.**
- 06. Bid should be signed by bidder/himself/themselves or a person duly authorized in this behalf. A copy of such authority should be enclosed along with the offer.
- 07. Bidders can inspect the unserviceable stores items during office hours (2.30 pm to 4.00 pm) at this Station from 29-07-2019 to 14-08-2019 in regard to the conditions, quantities etc. unserviceable surplus stores and satisfy themselves before submitting their offer by the date and time specified above. The rate should be quoted in figures & words.
- 08. Rates should be kept valid for acceptance at least for 90 days from the date of opening of bid.
- 09. The GST and other taxes levy if any, as applicable will have to be remitted by the successful bidder to the concerned Department before lifting of the unserviceable articles from this Regional Station. A copy of the receipt in token of having remitted to the GST should be submitted to the office.
- 10. Bid will be opened on 16-08-2019 at 11.30 AM. If the date of opening of bids happen to be holiday, then the bids shall be opened on the next working day of the same time.
- 11. It will be presumed that the bidders before submitting the offer have read carefully all the terms & conditions and accepted the same in full. Deviations from the terms & conditions as given in this are not permitted. Any such conditional bid and/or telegraphic bid is liable to be rejected and no alterations shall be allowed after the bid is submitted. No counter terms & condition shall be accepted.
- 12. Right to include any other conditions or modify or alter any of bid conditions already stipulated is reserved by the Acting Head, ICAR-CPCRI Regional Station, Kayamkulam.
- 13. Bidder will be deemed to have been on the clear understanding that they have satisfied themselves full in regard to the conditions, quality and quantity of unserviceable store proposed to be auctioned.

#### **PAYMENT AND DELIVERIES:**

The successful bidder will be required to make full payment of bid by demand Draft drawn on any nationalized bank in favour of ICAR UNIT, CPCRI (RS) payable At Kayamkulam within two days thereafter. Earnest money deposit shall be forfeited if payment in full is not made or the offer is withdrawn during the validity period. The successful bidder will have to lift the unserviceable store items within two days after depositing the full bid amount as per terms and conditions of the bid. Deliveries shall be affected against receipt of payment. Any bidder failing to lift the material within the above stipulated period shall have to pay ground rent @10% of tendered value per week. The Institute will not be responsible for any loss or damage of the unserviceable items. Earnest Money deposited shall be forfeited if any purchaser fail to lift the items after making full payment and expiry of period as mentioned above. Thereafter CPCRI shall be entitled to resell these items. No notice shall be issued to the bidder in this regard.

The purchaser will not be entitled to resell any or all unserviceable items while they are still lying within the premises of ICAR-CPCRI and no delivery would be affected by ICAR-CPCRI to any person or persons other than the purchaser/purchasers whose name /names are mentioned in the delivery order.

The successful bidder before actually collecting purchased unserviceable items should contact the Scientist-in-charge (Farm), ICAR-CPCRI, Kayamkulam to get the gate pass and delivery of unserviceable materials.

Loading, handling and transportation shall be the sole responsibility of the purchaser at his/her own cost.

Loading and lifting of the auctioned goods shall be done by the purchaser only during the prescribed working hours of the Institute. No deliveries shall be affected during Sunday or Holiday.

The Acting Head, ICAR-CPCRI reserves the right to accept or reject any or all offer/bids either in full or in part without assigning any reason whatsoever.

If sufficient bids are not received, the Acting Head, ICAR-CPCRI, Kayamkulam reserves the right to call for fresh bids. In such an event Earnest money deposited by the bidder shall be refunded.

The earnest money deposited by the successful bidder shall be refunded in full without any interest after lifting the bid items as per the terms & conditions stipulated in the quotation notice.

The successful bidder shall be responsible for any damage that may be done to the premises while removing the goods by him. The Acting Head, ICAR-CPCRI, Kayamkulam may at his own options ask to make good such damages and buyer shall have to pay for the same on demand.
