Instruction for Online Bid Submission:

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal. More information useful for submitting online bids on the CPP Portal may be obtained at: www.eprocure.gov.in.

REGISTRATION:

Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (**url:** https://eprocure.gov.in/eprocure/app) by clicking on the link 'Click here to Enroll'. Enrolment on the CPP Portal is free of charge.

As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.

Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.

Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India with their profile.

Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others, which may lead to misuse.

Bidder then logs into the site through the secured login by entering their user ID / password and the password of the DSC / e Token.

SEARCHING FOR TENDER DOCUMENTS:

There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a tender published on the CPP Portal.

Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective `My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / E-mail in case there is any corrigendum issued to the tender document.

The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

PREPARATION OF BIDS:

Bidder should take into account any corrigendum published on the tender document before submitting their bids.

Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents – including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.

Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF formats. Bid documents may be scanned with 100dpi with black and white option.

To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use `My Space' area available to them to upload such documents. These documents may be directly submitted from the `My Space' area while submitting a bid, and need not be uploaded repeatedly. This will lead to a reduction in the time required for bid submission process.

SUBMISSION OF BIDS:

Bidder should log into the site well in advance for bid submission so that he/she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.

The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.

Bidder has to select the payment option as 'offline' to pay the EMD as applicable and enter details of the instrument(s).

Financial bids to be submitted in XLS format.

The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission,

All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bid encryption technology. Data storage encryption of sensitive fields is done.

1. Locations for the Work

The entire works as described in Schedule of Requirements must be undertaken at ICAR – Central Plantation Crops Research Institute, RC, Kahikuchi, P.O. Azara, Guwahati, Assam, India

3. Eligibility Criteria:

- a. The bidder should have executed similar type of orders with other Central / State /PSU /Govt. Societies for a minimum of 3 years.
- b. The bidders should submit the required documents / financial instruments as stipulated in para 3 of Annexure I.
- c. The bidder must not be blacklisted by ICAR-CPCRI, Kasaragod or any other Educational/R&D/Govt. organizations. A certificate or undertaking to this effect must be submitted.

4. Amendment to Bidding Documents

- 4.3 ICAR-CPCRI, RC, Kahikuchi at its discretion may extend the deadline for the submission of bids if it thinks necessary to do so or if the bid document undergoes changes during the bidding period, in order to give prospective bidders time to take into consideration the amendments while preparing their bids.

- 9.1 The technical bids will be evaluated in two steps.
- The bids will be examined based on eligibility criteria stipulated at Annexure II to shortlist the eligible bidders.
- The technical bids of only the short listed eligible bidders shall be evaluated based on technical specifications stipulated at Annexure I.
- 9.2 The bidders whose technical bid is found to meet both the requirements as specified above will qualify for opening of the Financial bid and will be informed about the date and time of the opening of the Financial bid.
- 9.3 The duly constituted Tender Evaluation Committee (TEC) shall evaluate the bids.

10. Comparison of Financial Bids

- 10.1 Only the short-listed bids from the Technical bid evaluation shall be considered for Financial bid comparison.
- 10.2 The Financial bids will be evaluated on the basis of prices quoted. The contract will be awarded to lowest.

11. Award of Contract

If any dispute arises between the firm / contractor and its manpower in the matter of wages or any service conditions the same will be settled amongst the agency and the workers engaged by it themselves. CPCRI, Kasaragod no case shall be a part to such a dispute. It shall be the responsibility of the firm / contractor to comply with the provision of all Acts and Government instructions. If any statutory provision of any statute is violated in general concerning the force employed and in regard to Welfare of the personnel engaged for the work on particulars, then the performance security will be confiscated and firm/contractor will be blacklisted.

The worker will remain the employees of the Agency / contractors and will be the solely responsibility of the agency. Therefore, there is no master and servant relationship between the employees of the service provider and this Institute and further that the said personnel of the service provider shall not claim for any employment or absorption in this Institute by virtue of their engagement for this work.

37. सेवा प्रदाता का कार्मिक किसी भी व्यक्ति से कार्यालय का विवरण, प्रचालन प्रक्रिया, तकनीकी जानकारी, सुरक्षा व्यवस्थाएँ, प्रशासनिक और संगठनात्मक मामलें जो कि ये सब गोबनीय प्रकृति का है, नहीं प्रकट करना होगा। सेवा प्रदाता यह सुनिश्चित करना होगा कि एजेंसी/ठेकेदार का किन्हीं भी व्यक्ति भा कृअनुप-केंरोफअसं, कासरगोड़ के विभिन्न कमरों में किसी भी प्रकार के निजी कार्य के लिए प्रवेश नहीं करेगा।

The Service provider's personnel shall not divulge or disclose to any person any details of office, operation process, technical know-how, security arrangements administrative and organizational matters as

all of these are confidential in nature. The Service provider shall ensure that none of the employees of the Agency / Contractor shall enter into any kind of private work at the different rooms of ICAR-CPCRI, RC, Kahikuchi.

38. सेवा प्रदाता यह सुनिश्चित किया जाए कि कार्यालय परिसर में उसके द्वारा नियोजित कार्मिकों का आचरण उचित है और मादक पेय/नशीले पदार्थ का उपयोग/ पैन और तम्बाकू पीना/ धूम्रपान, मोबाईल फोन /ईयर फोन का उपयोग/गीत सुनना और बिना कार्य कर घूमना आदि के निषेध के लिए प्रवर्तन करें।

The Service provider shall ensure proper conduct of its personnel in office premises and enforce prohibition of consumption of alcoholic drinks / drugs /chewing of pan & tobacco /smoking, using mobile phone / ear phone and listening music and loitering without any work.

39. फर्म का कार्य और/उसके कर्मचारी के कारण भाकृअनुप-केंरोफअसं,आर सी, किंहकुचिसंपित को यदि कोई क्षिति हो जाए और एजेंसी/फर्म द्वारा ठीक करा दिया जाएगा । और इस संबंध में संस्थान का निर्णय अंतिम और बंधक होगा ।यदि कर्तव्य की कोई अवहेलना, घोर उपेक्षा हो जाए, ठेकेदार/या उसके स्टाफ द्वारा पहुँचाई गई अनिभेप्रेत क्षिति/नष्ट या अन्यथा कोई हानि भाकृअनुप-केंरोफअसं,आर सी, किंहकुचि, उसकी संपित , नामित अधिकारी या कर्मचारी को हुई है तो नष्ट को ठीक करने में ठेकेदार बाध्य होगा या भाकृअनुप-केंरोफअसं,आर सी, किंहकुचिके साथ प्रतिपूर्ति अदा करना, कानूनी/न्यायिक कार्यवाही व्यय चुकाना तथा अर्थदंड अदा करना, जो अनुरूप समझा जाए।

The damage caused, if any, to ICAR-CPCRI, RC, Kahikuchi property through the acts of the firm and / or by its employee shall be made good by the Agency / firm and decision of this Institute in this regard shall be final / binding. Incase of any dereliction of duty, gross neglect and unintended damage / loss caused by contractor or its staff or otherwise any harm done to the ICAR-CPCRI, RC, Kahikuchi, its properties its designated officials or other employees, the contractor shall be liable to make good the loss or pay compensations, refund expenditure legal / judicial proceedings as well as pay penalty with the Scientist In-Charge, ICAR-CPCRI, RC, Kahikuchi may deem, fit.

40. संविदा अविध में कर्मचारियों की संख्या बढ़ाने और कम करने का अधिकार निदेशक ,भाकृअनुप-केरोफअसं, कासरगोड़ पर आरक्षित है । और पर्याप्त आधार के बिना संविदा सकारने में चूक हुआ तो उपयुक्त अविध के लिए निष्पादन स्रक्षा जब्त करने और एजेंसी को रोकने का अधिकार भी आरक्षित है ।

The Director, ICAR-CPCRI, Kasaragod reserves the right to reduce or increase number of employees during the contract period & also have the right to debar the agency and forfeit the Performance security for a suitable period in case, he fails to honour the contract without sufficient ground.

The Director, ICAR-CPCRI, Kasaragod informed the Firm / The Contractor shall abide by all laws of the land including labour laws, company act, tax deduction liabilities, welfare measures of his employees and all other obligations that enjoy in such cases and other not essentially enumerated and defined therein. Though any such onus shall be exclusive responsibility of the contractor, and it shall not involved ICAR-CPCRI, Kasaragod in any way whatsoever.

The ICAR-CPCRI, Kasaragod reserves the right to ask and requires the contractor to terminate the employee if he/she failed to perform his/her duty / break the rules & regulation of the contract, and the Firm / Contractor should take necessary action for the same in the stipulated time period, failing which leads termination of Contract and blacklisting the Firm / Contractor for further tendering of this Institute.

43. एजेंसी/ठेकेदार अपने कर्मचारियों के अच्छे आचरण और आचार में उत्तरदायी हो जाएगा । यदि एजेंसी/ठेकेदार का कोई कर्मचारी भाकृअनुप-केंरोफअसं आर सी, किह्कुचिके स्टाफ सदस्य या भाकृअनुप-केंरोफअसं आर सी, किह्कुचिमें कार्यरत एजेंसी के अन्य स्टाफ के साथ दुराचरण पाया जाए तो एजेंसी/ठेकेदार तुरंत ही ऐसे कर्मचारियों को अपना स्वयं दायित्व / उत्तरदायित्व में तत्काल लौटाएगा।

The agency / contractor shall be responsible for the good conduct and behavior of his/her employees. If any employee of the agency / contractor is found misbehaving with ICAR-CPCRI,RC, Kahikuchi staff or other staff of agencies working in ICAR-CPCRI, Kasaragod, the agency / contractor shall immediately withdraw such employees forthwith at their own risk, responsibility and liability.

The Service provider shall in no case pay his employees less than the minimum mandatory rates per day / month as announced by the State Government of Central Labour Commissioner from time to time. The payment should be made directly in to the bank A/c of the worker through NEFT and copy of the statement of NEFT should be enclosed with the quarterly bill.

45. केरोफअसं को दी गई सेवा के कारण संबंधित सांविधिक प्राधिकारों को समय - समय पर संविदाकर्ता एजेंसी दवारा कोई कर , उगाही, सेसआदि जमा करने के लिए बाध्य है ।

The tendering agency shall also liable for depositing any taxes, levies, cess etc. on account of service rendered by it to the CPCRI, RC, Kahikuchi to the statutory authorities concerned from time to time.

In case, the service provider / Agency fails to comply with any statutory /taxation liability under appropriate law, and as a result thereof the Institute is put to any loss /obligations monetary or otherwise, the Institute will be entitled to get itself reimbursed out of the outstanding bills or the Performance Security Deposit of the agency, to the extent of the loss / obligation in monetary terms.

The Agency/Contractor shall not appoint Sub-Contractor to carry out any obligation under the contract and under such case agreement will be declared as void and such act of contractor will be taken as breach of contract and resultantly his Security deposit shall be forfeited and contract shall be terminated.

The contractor will discharge all his legal obligation in respect of the workers / supervisors to be employed/deployed by him for the execution of the work in respect of their wages and other service conditions and shall also comply with all the rules and regulations and provisions of law in force that may be applicable to them from time to time.

50. ठेकेदार द्वारा नियोजित कार्मिकों में किसी को सुरक्षा जोखिम ,असमर्थता, अधिकार का विरोध, गोपनीयता का भंग, के कारण इस संस्थान को अस्वीकार्य है या ठेकेदार उसको गलत आचरण के कारण केंरोफअसं आर सी, किह्कुचिके किसी स्टाफ सदस्य से लिखित सूचना प्राप्त करने पर तत्काल प्रतिस्थापित करेगा और बिना देरी उचित प्रतिस्थापन प्रदान करेगा।

The Service provider shall replace immediately any of its personnel, if not unacceptable to this Institute because of security risk, incompetence, conflict of interest and breach of confidentially or improper conduct upon receiving a written notice from any staff of CPCRI, RC, Kahikuchi and also provide suitable replacement without delay.

If Tenderer does not accept the offer after issue of letter of award by Institute within 15 days, the offer made shall be deemed to be withdrawn without any notice and EMD will be forfeited.

However the Service taxes or any other tax which is as per the rules of the Govt. shall be deducted at source from quarterly bills of the successful Tenderer, as per rules / instructions made applicable from time-to-time by Govt.

53. बीजक में बीजक संख्या, फर्म /ठेकेदार का पता, जी एस टी,जी एस टी संख्या (फार्म और भाकृअनुप- केंरोफअसं,आर सी, किंकुचिदोनों) स्थायी लेखा संख्या , बैंक विवरण , सेवा विवरण, सेवा खर्च आदि प्रत्येक रूप से सूचित किया जाना चाहिए ।

The Invoice should contain, invoice number, address of the firm / contractor, details of all taxes including GST, GSTIN (both firm and ICAR-CPCRI, RC, Kahikuchi), PAN and Bank details, service description, service charge etc should be indicated separately.

54. स्टाफ/पर्यवेक्षक को बदलाते समय संबंधित प्रभारी अधिकारी, केंरोफअसं आर सी, किंकुचिको सूचित किया जाए ।

Changing of Staff/Supervisor should be intimated to concerned Officer in-charge, CPCRI, RC, Kahikuchi.

Payment for service contract can be made quarterly upon submission of pre-receipted bill and I.D, statutory levies are duly paid with relevant proof to office.

56. नियम के अनुसार किए गए कार्य के लिए देय भुगतान से आयकर की कटौती की जाएगी। Income tax will be deducted from the payments due for the work done as per rules. 57. ठेकेदार केवल प्रौढ श्रमिकों को तैनात करना है। बाल श्रम का रोज़गार संविदा समाप्त करने का कारण हो जाएगा

The contractor must employ adult labour only. Employment of child labour may lead to the termination of the contract.

The contract is subject to the condition that the conditions in the tender will comply with all the law and acts of Central/State Govt. relating to this contract applicable from time to time.

The tenderer is being permitted to give tenders in consideration of the stipulations on his part that after submitting his tenders, he will not take back his offer or modify the terms and conditions thereof. If the tenderer fail to observe and comply with the foregoing stipulation the aforesaid amount of EMD will be forfeited by the Institute. In the event of the offer made by the tenderer not being accepted, the amount of earnest money deposited by the tenderer will be refunded to him in the manner prescribed by the Institute.

Other conditional Tenders will not be accepted.

However the income tax or any other tax which isas per the rules of the Govt. shall be deducted at source from quarterly bills of the successful tenderer, as per rules/instructions made applicable from time to time by government.

The contractor shall provide full particulars of each employee including their antecedents verification etc., employed by him along with photograph duly attested before start of the work and from time to time. He will also endorse a copy of returns furnished by him to the labour department under the contract labour (Regulation and Abolition) Act 1970.

65. केंद्रीय श्रम आयुक्त/केरल राज्य सरकार द्वारा निर्धारित विद्यमान निम्नतम मज़दूरी पर आधारित दर कोई भी उच्च हो, उद्दत किया जाना है । भाकृअनुप-केंरोफअसं,आर सी, किंहकुचिकिसी लेखा पर चाहे जो भी अर्थात कर्मचारी भविष्य निधि अंशदान, वर्दी, समयोपिर यात्रा भत्ता आदि पर कोई अतिरिक्त ऋण- भार वहन नहीं करेगा।

The rates to be quoted based on prevailing minimum labour wages prescribed by the Central Labour Commission/Assam State Govt. whichever is higher. The ICAR-CPCRI, RC,Kahikuchi shall not bear any extra Charge on any account whatsoever i.e. EPF contribution, Uniform, Liveries, OTA, etc.

The quantum of work is approximate and it may increase or decrease as per need and at the discretion of the Scientist In-Charge, CPCRI, RC, Kahikuchi.

Any compensation paid to the worker or parties hired through Contractor, shall be recovered from the Contractor as per the guidelines issued by ICAR vide O.M No. Admn-22(6)/2018-Estt.III dated 31.07.2018.

तरल क्षतियाँ शर्तLIQUIDATED DAMAGE CLAUSE

संविदा राशि के दो दिन का समतुल्य राशि तरल क्षिति के रूप में प्रिति दिन बशर्तें कि निम्नतम प्रिति महीना5% चन्दा लगाया जाएगा। जब और जहाँ भी किसी भी अनुभाग में सेवाएँ संतोषजनक नहीं /मार्क तक नहीं पाया जाता है ,संस्थान द्वारा फार्म के पर्यवेक्षक स्टाफ के नोटिस में लाया जाएगा और यदि एक घंटे के अंदर कोई कार्रवाई नहीं की जाएगी तो तरल क्षिति शर्त आहवान किया जाएगा।

An amount equivalent to two days of contract amount, subject to a minimum of 0.5% per month will be levied as liquidated damage. Whenever and wherever it is found that the work is not up to the mark in any section, it will be brought to the notice of the supervisory staff of the firm by the Institute and if no action is taken within One Hour liquidated damages clause will be invoked.
